

ARTICLES OF AGREEMENT made this 25th day of November
1916, by and betwee, the UNITED BOTUSHANER AMERICAN BROTHERLY
BENEVOLENT ASSOCIATION, of the City of New York, a Society
duly organized under the Laws of the State of New York, party
of the first part, and SURA BEILA WECHSLER, residing at #

WITNESSETH, ; -That the party of the first part, in con-
sideration of the sum of one hundred Dollars, (\$100,00),
lawful money of the United States, paid by the party of the
second part to the party of the first part, the receipt where-
of is hereby acknowledged, do hereby sell grant and release
unto the said party of the second part, ALL THAT certain lot,
piece or parcel of land, situate, lying and being in Washington
Cemetery, in the County of Kings , City and State of New York,
in Section one, and known by grave number as grave No, 9 , in
the first line, next to the grave of Mrs, LIEBER, in the part
of Cemetery belonging to the United Botushaner American
Brotherly Benev, Ass'n.

TO HAVE AND TO HOLD THE SAME unto the said party of the
second part forever, as a place of burial exclusively for the
said SURA BEILA WECHSLER after her demise, and for no other
person whatever,

AND it is expressly agreed between said parties, that in
the event by reason of remarrying or by any other cause the
sai SURA BEILA WECHSLER shall change her mind about using
said grave for the burial of her body after her demise, she
shall not have the right to sell or give away said grave to
no person whatever, but to return same to the UNITED BOTU-
SHANER AMERICAN BROTHERLY BENEV, ASS'N with the price of
fifty Dollars, and the party of the first part agrees to pay
to the party of the seecnd part the sum of fifty Dollars
for said grave at any time she may desire.
